Other Charges Added to Tuition Payment Plan

- 1) **LATE ENROLLMENT FEE** - A late enrollment fee of \$100 per child will be added to the tuition agreement if a family does not complete the enrollment process and set up a tuition payment plan on or before the designated due date, June 3rd 2019.

- 2) **NON-PARTICIPANT FUND RAISER FEE** - If a family does not fulfill their fund raising obligations as committed to during enrollment, a non-participant fund raiser fee of either \$350 or \$700 will be added to the April tuition payment as directed by the Home and School Association President. The amount will be determined based on the extent the family fulfilled their original participant commitment during enrollment.
