1. The first drawing will be Saturday, March 2, 2019 at 4:00 PM at Quigley’s Irish Pub. Only one (1) ticket will be drawn each week. Winner need not be present.
2. When the drawing falls on a holiday, we will freeze the drawing until the following Saturday. There will be NO drawings on Saturday, March 16, 2019 and Saturday, April 20, 2019. Saints Peter and Paul reserves the right to adjust the drawing dates based on Saints Peter and Paul School and/or Quigley events.
3. Queen of Hearts raffle ticket sales will begin on Saturday, February 16, 2019 at 11:30am at Quigley’s Irish Pub located at 43 E. Jefferson Avenue, Naperville, IL 60540. There will be NO ticket sales from Thursday, April 18, 2019 through and including Saturday, April 20, 2019.

Ticket sales on drawing days will END at 3:45 pm sharp and all tickets must be placed in the drum by 3:50 pm so get there early!! Ticket sales will resume after the drawing if the Queen of Hearts is not revealed until 8:00 pm.

5. Tickets are one (1) for \$5, and you can buy as many as you wish. **CASH ONLY** at Quigley's, Advancement Office and before and after weekend Masses.
 - ***On line ticket sales Credit Card ONLY***
6. If the Queen of Hearts is not revealed on the date of the drawing, raffle ticket sales will begin for the next week's drawing following a reasonable amount of time to allow for volunteers to set up selling raffle tickets. Ticket sales will end at 8:00pm each Saturday.
7. All players and winners must be 18 years of age.
8. Fifty four (54) playing cards including two jokers are placed face down on a mounting board purchased from a certified gaming vendor; the cards are numbered one (1) through fifty four (54) and are sealed to the board.
9. Once a card is selected, it will be turned over with the card face up on the board. If the Queen of Hearts is not selected the game will rollover to the next week. After the drawing, all tickets for that week's drawing will be removed and managed in accordance with city ordinances, county and state laws.
10. There can be only one name per ticket. Each ticket purchaser must include their full name, as it appears on their driver's license or social security card, phone number AND the number of the available card they are requesting. Do not use nicknames, initials, group names or abbreviations as this could cause complications when collecting any winnings.
11. Each purchaser of a raffle ticket or tickets must also provide their full name and home address as required by City of Naperville ordinance. If purchaser does not want to provide their home address then they will not be eligible to purchase raffle tickets.
12. If a person does not put a phone number on their ticket, the ticket will be thrown out and there will be an automatic rollover. No award money will be distributed.
13. If a ticket is pulled and it has a number that has already been taken, the ticket will be thrown out and there will be an automatic rollover. No award money will be distributed.

14. This raffle is scheduled to last no longer than 180 days from the start of ticket sales, February 16, 2019 (per City of Naperville ordinance). If the Queen of Hearts is not revealed during the Saturday drawings (not to exceed 180 days), we will continue to pull a ticket on Saturday, August 10, 2019, the date of the last drawing, until the Queen of Hearts is revealed.
15. The cap for this raffle will be total gross ticket sales of \$2,000,000 (per City of Naperville ordinance).
16. Ticket sales will end once the \$2,000,000 allowable cap is reached. The Queen of Hearts drawing will then take place on the first Saturday immediately following when the \$2,000,000 allowable cap is reached. When the last ticket is pulled and it has an unavailable card number on it, we will continue to pull raffle tickets until the Queen of Hearts is revealed.
17. The winner of this raffle shall win 50% of the money generated from gross ticket sales net of 50% of any fees and expenses incurred by Saints Peter and Paul to conduct the raffle.
18. The other 50% of the money generated from gross ticket sales net of 50% of any fees and expenses incurred by Saints Peter and Paul to conduct the raffle shall be retained by Saints Peter and Paul School and applied to lawful uses for the benefit of Saints Peter and Paul School.
19. The total prize pool will continue to accumulate weekly until the Queen of Hearts is drawn. The jackpot amount, based on ticket sales, will be updated and displayed on a designated Queen of Hearts raffle Facebook page administered by the Saints Peter and Paul Queen of Hearts committee. Projected total raffle updates will be posted on both the school and parish websites. A projected total raffle pot amount will be posted inside Quigley's.
20. All winnings greater than \$600 (less the cost of the wager) but less than \$5,000 are subject to IRS tax reporting rules. The winner of prizes greater than \$600 but less than \$5,000 must provide proper identification for the prize to be awarded. The Saints Peter and Paul Parish Finance office will report winnings greater than \$600 but less than \$5,000 to the IRS.

21. If a prize of greater than or equal to \$5,000 is awarded, the winner will need to present and confirm (i) their identity with a valid driver's license or passport (must present an ID that contains a photo), (ii) their SSN number and (iii) complete and sign an IRS Form W-2G. In addition, the IRS requires a withholding of 24% of the winnings less the amount of the wager. The winner must schedule an appointment with the Saints Peter and Paul Parish Finance office to complete the required tax reporting documents. Withholdings will be remitted to the IRS by the Saints Peter and Paul Parish Finance office.
22. Winnings (net of taxes) will be issued in the form of check.
23. Winnings (net of taxes) will not be distributed until the winner's identification has been confirmed and the W-2G has been completed and signed. If a player is unwilling or unable to provide any of the listed items, the prize money will revert to the school. The winner must allow for up to two weeks from completion of the paperwork to the receipt of the winnings.
24. A winner cannot donate the prize without first taking ownership of the prize, which means the appropriate W-2G must be issued and the appropriate withholding taken. If a winner then wants to donate the prize he/she can do so.
25. All members and their spouses of the School Advancement Board, and the Advancement Director, School Principal and Parish Finance Manager and their spouses are **NOT** eligible to purchase raffle tickets for the Queen of Hearts raffle.
26. If you do not agree with the rules of this game at this venue, there is no obligation to play.

The Queen of Heart's Committee reserves the right to amend these rules as needed prior to any week's drawing. The Committee also retains the right to change the date or location of the drawing as needed.

These Official Rules cannot be changed by any oral statement made by any employee, consultant or agent acting on behalf of Saints Peter and Paul (SSPP). By entering the Raffle, entrants accept and agree: (1) to be bound by these Official Rules and the decisions of SSPP which shall be final and binding; (2) waive any right to claim ambiguity in the Raffle or these Official Rules; (3) that SSPP may use the entrant's name, photograph, likeness, statements, or voice for promotional or advertising purposes in connection with the Raffle in all forms of media, now or hereafter known, in perpetuity, without review, permission or further compensation, except where prohibited by law.

IN NO EVENT SHALL SSPP, ITS DIRECTORS, OFFICERS, EMPLOYEES, AGENTS, REPRESENTATIVES OR VOLUNTEERS BE LIABLE TO ANY PARTY FOR ANY LOSS OR INJURIES TO EARNINGS, PROFITS OR GOODWILL, OR FOR ANY INCIDENTAL, SPECIAL, PUNITIVE OR CONSEQUENTIAL DAMAGES OF ANY PERSON OR ENTITY WHETHER ARISING IN CONTRACT, TORT OR OTHERWISE, EVEN IF ADVISED OF THE POSSIBILITY OF SUCH DAMAGES. ANY CONTROVERSY OR CLAIM ARISING OUT OF OR RELATING TO THE RAFFLE OR THESE OFFICIAL RULES SHALL BE SETTLED BY BINDING ARBITRATION ADMINISTERED BY THE AMERICAN ARBITRATION ASSOCIATION (PURSUANT TO ITS EXPEDITED PROCEDURES) UNDER ITS COMMERCIAL ARBITRATION RULES AND CONDUCTED IN DUPAGE COUNTY, ILLINOIS. JUDGMENT ON THE AWARD RENDERED BY THE ARBITRATOR MAY BE ENTERED IN ANY COURT HAVING JURISDICTION THEREOF.

Cancellation/Termination of Raffle: By purchasing a Ticket and choosing to participate in the Raffle, each Raffle participant acknowledges and agrees that SSPP has the right, in its sole discretion, to elect not to proceed with the Raffle for any reason whatsoever or for no reason.
